Record-note of the meeting chaired by Shri D.S. Poonia, Chief Secretary, Manipur for review of housing/Government accommodation held on 20-10-2011 at 11.00 a.m.

List of members present is annexed.

2. It was noted that there are 800' (eight hundred) houses at National Games Village (NGV). The break up of these houses is as given below :

- i. 300 houses - with P.W.D.
- ii. 362 houses - with Police Department.
- iii. 138 houses - with PDA (now 135 houses excluding 3 houses gifted to individuals).

3. There are also some structures at Khuman Lampak Sports Complex which are constructed with loan from HUDCO.

4. There are altogether 1864 (one hundred eight hundred sixty four) Government quarters with P.W.D. as given below :

The list occupants of the above government quarters indicating outstanding dues of rent was placed in the meeting.

5. After deliberations, the following decisions were taken :-

- i. P.D.A. to initiate action against unauthorised occupants of 135 houses at NGV. P.D.A. also to collect arrears of rent at penal rates from the unauthorised occupants. Works Department will put-up the representation of the private individuals to Hon'ble Minister(Works) for a decision.

Action : Principal Secretary (Works) & Secretary (PDA).

- ii. 362 houses at NGV to remain with Police Department. Police Department to collect rent on monthly basis from Police personnel allotted the accommodation and deposit into relevant Head of Account through Treasury Challan with copy to Home & Finance Departments.

Action : IGP (Adm).

- iii. The Khuman Lampak Sports Complex (KLSC) structures to remain with YAS Department.

Action : Commissioner (YAS)

- iv. DDO-wise lists of defaulting Government employees who fail to pay rents/outstanding dues shall be circulated by Works Department/PWD to Heads of Departments with a copy to Administrative Secretaries concerned for recovery within stipulated time-line. Lists of defaulting employees separately for State Government and Central Government etc. to be loaded on the website Works Department page in *manipur.gov.in* through Shri Bikramjit and Shri Marth Khuman of DIT, Manipur. Works Department/PWD to formulate a module for training of DDOs at State Academy of Training.

Action : Principal Secretary (Works) & Chief Engineer, PWD.

- v. A new Plan Scheme for improvement/upgradation of Government quarters and construction of new quarters to be proposed by PWD under 12th Plan.
